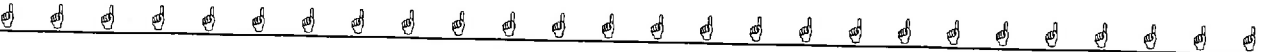

APPROVAL OF MINUTES OF MAY 7, 2015 -approved

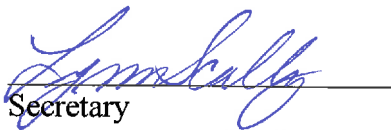
