Dear Residents and Property Owners:

The purpose of this notice is to provide information on an upcoming project in your community by the Santa Cruz County Sanitation District.

The project will replace the existing sewer force main between the Soquel Pump Station and Clares Street. The project will help protect water quality at Capitola Beach by reducing the threat of a force main failure, with possible sanitary sewer overflow into Soquel Creek, and will increase sewer system operational reliability, flexibility, and response time. The project also involves necessary improvements to the Soquel Pump Station including the replacement of existing large diameter valves, flow meters, odor ventilation upgrades, electrical instrumentation, and concrete repairs within the building.

Normal working hours for construction of the project will be from **7:30 a.m. to 5:00 p.m.** All work involving heavy equipment or traffic control will be done between the hours of **8:30 a.m. and 4:30 p.m.** At times during the project, residents in the area should expect **construction noise, dust, temporary traffic control and detours, and associated traffic delays.** Access to driveways on Clares Street may be temporarily blocked during construction. In addition, sewer service to properties on Clares Street may be temporarily interrupted during working hours.

Residents on Clares Street will be given advanced notice prior to any work impacting their driveways or sewer service. Access to businesses in the area will be maintained throughout each phase of construction.

Thank you in advance for your patience during construction. We will be holding a construction informational community meeting to answer any of your questions.
