

Project Overview


Why is this a proposed project?

- Existing Santa Cruz County Facilities at capacity
- 2. Buena Vista Landfill expected to reach capacity 2030-2034
- 3. Continue to provide solid waste services in Santa Cruz County
- 4. Meet State and County regulations
- 5. Reduce illegal dumping
- 6. Reduce traffic on Highway 1



Proposed Landfill Redevelopment Project

- 1. Develop 2 new waste transfer stations
- 2. Develop an organics diversion facility
- 3. Implement the landfill closure plan



Proposed Redevelopment Project concept, 2024





FIGURE 1. BUENA VISTA LANDFILL REDEVELOPMENT PROJECT OVERVIEW

Completed landfill "Old Landfill"


Final EIR Proposed Buena Vista Sanitary Landfill Expansion 1985




Landfill Task Force Closure Studies

2000: Task Force evaluated post closure options

2004: Citizens Advisory Group (CAG) Siting Study recommendation to County Board of Supervisors = No further consideration of new landfills




CAG Siting Study, 2004

Environmental Review Process


Purpose and Requirements of CEQA

- 1. Inform decision making
- 2. Disclose potentially significant environmental impacts
- 3. Identify mitigation measures
- 4. Foster public participation and interagency coordination

CEQA = California Environmental Quality Act

The EIR Process

EIR = Environmental Impact Report

The "No Project" alternative is required


